In the spring of 2004, each Common Stock Right will be exchanged for one share of Common Stock; provided, however, Dr. Golde will be entitled to elect to receive cash for up to 50% of these rights, with the price per right being \$11.97, the fair market value of Enzon's Common Stock on December 31, 2003.
- Each Common Stock Right that is exchanged will be exchanged for one share of Enzon's Common Stock.
- Annual option granted to the Independent Directors of Enzon pursuant to Enzon's 2001 Incentive Stock Plan and qualified under Rule 16b-3(d).
